SALES VOLUME IN APRIL 2012**

This is a voluntary announcement made by Geely Automobile Holdings Limited (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that the total sales volume of the Group for the month of April 2012 was 36,582 units, an increase of approximately 4.8% over the same period last year, but was down approximately 11.4% from March 2012. The total sales volume in the first four months of 2012 was 155,078 units, up 1.6% from the same period last year and achieving 33.7% of the full year sales volume target of 460,000 units in 2012.

During the month of April 2012, the Group’s sales volumes under “Emgrand”, “Englon” and “GLEagle” brands were 9,974 units, 11,750 units and 14,858 units, respectively.

Please note that the sales volumes above are unaudited figures and have not been confirmed by the Company’s auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors are advised to read carefully the financial results of the Group when it is published.
